### FROM WESTERN AUSTRALIA

Western Australia is the newest state to be nationally represented by ARCIA. ## OUR WORK

The ARCIA Committee and ex-officio members meet monthly and are each involved in various Association sub-Committees including Technical and Spectrum, Training and Education, Events, Membership, and Accreditation. Below you will find reports detailing the work of each sub-Committee over the last 12 months.

### TECHNICAL AND SPECTRUM

This year has again seen quite a bit of activity from the Spectrum & Technical sub-Committee. We have responded on behalf of our members to several ACMA requests for public submissions, plus met with ACMA representatives for meaningful discussions on a range of subjects.

The year saw the finalisation of the ACMA review of the 400MHz band, with many of the recommendations made by ARCIA being taken up in the final outcome and so the interests of our members and industry have been protected. During the year, we also submitted a list of items for inclusion in the ACMA Five Year Spectrum Outlook, although these specific items have not been included in the work plans at this stage, they have been acknowledged by the ACMA as areas that do require attention and we will continue with our representations in this area.

Throughout the year we have also been active within the Standards area with Noel Higgins representing ARCIA on the Standards Australia RC004 and RC006 working groups. It is pleasing to see that the RC006 committee under Noel's chairmanship and with input on ARCIA's behalf, have revised the AS/NZS 4365 UHF CBRS standard including simplification of the channel numbering arrangements. This allowed the revised UHF CB narrowband channel arrangements of the 400MHz UHF band replan to be implemented through a new ACMA standard and amendments to the ACMA Class licence.

From an ARCIA perspective, it is pleasing to note that many of the features we pressed for implementation into the 400 MHz band are also reflected in the UHF CB standards. Looking to the future, we have concerns about the present methodology with regard to Equipment Standards and we are working in conjunction with ACMA to look at ways of easily adopting overseas standards to facilitate the ease of entry into the Australian market of new technologies, especially in the digital domain.

As this Annual Report is being prepared, the ACMA are conducting a review of the 900 MHz band, plus a partner enquiry into 'The needs for Broadband data looking ahead to 2020'. ARCIA will be responding to the various stages of these enquiries, especially in regard to the historical utilisation of the 900 MHz spectrum, as well as considering whether the future needs to continue with the present format for 900 MHz Land Mobile usage, or do we need to explore other opportunities.

In addition to the attendance of our New South Wales representatives at the ACMA Radcomms 2011 conference in Sydney in May 2011, Noel Higgins attended on behalf of the Spectrum & Technical sub-Committee and details of the conference were subsequently circulated to our members via the regular Member Update and also posted on the ARCIA web site.

ARCIA also takes available opportunities to represent the best interests of our members in other areas. This year we have conducted a small survey on representative labour rates used by our members to allow a Government agency in one state to have a 'frame of reference' for establishing realistic and reasonable labour rates payable for services to Government. It is the intention of ARCIA to expand this into an annual survey of all interested members.

ARCIA are also considering the implementation of an independent audit system for the sales of radio 'terminals' in Australia, where hopefully manufacturers/suppliers can advise an independent body of their monthly sales of product to give statistics available through ARCIA regarding the relative size and health of the Radio Communications Industry.

# ARCIA AND ACMA - A BROAD SPECTRUM OF COOPERATION

We are very pleased with the developing relationship between ARCIA and the ACMA.

Only a couple of years ago one ACMA staff member was warned to be careful in his dealings with any supposed Industry group from the Land Mobile sector, 'They were just rabid zealots without any real under-standing of the overall spectrum requirements'.

We can now very happily report that we have a strong relationship with the ACMA, evidenced by:

• The Chairman of the ACMA (Mr Chris Chapman) attending our Annual Gala Dinner in Melbourne and accepting an Award to recognise the ACMA being so committed to stakeholder input with regard to the 400 MHz band plan review;

• ARCIA being invited to be involved and present information at each of the seven ACMA Road Shows which were used to present information and seek response regarding the final outcomes of the 400 MHz review;

• ARCIA distributing the latest 'Spectrum Usage' chart from the ACMA from the ARCIA stand at RadioComms Connect 2010;

• ACMA accepting an invitation to provide a guest speaker (Andrew Stewart) at the ARCIA Perth National Networking Event in June 2011.

ARCIA continues to develop this relationship based on the underlying premise that a cooperative and constructive relationship is in the best interests of both organisations. This is genuinely a case of the 'Odd Couple' actually having much in common and being able to achieve much by combining with common goals.

## TRAINING AND EDUCATION

The last year has seen a continuation of our relationship with RMIT University in Melbourne, with involvement in Industry Advisory Committees (IAC), and providing both student encouragement through our involvement with the ENgenius program. Our IAC involvement has also included liaison with Engineers Australia, which saw the formal accreditation of RMIT's Associate Degree Programs, the first in Australia.

ARCIA member JRD Communications has sponsored student visits to their communications sites and workplace, and offered student work placements providing exposure to radio communications.

We encourage all member organisations to take the initiative to liase with their local Registered Training Organisation (RTO), be it a University or a TAFE, to offer workplace visits or guest lectures to introduce the idea of a career in radio communications to their students. Work placements can be a valuable means of assessing potential employees.

There is some concern that radio technicians require, as a minimum, the competencies afforded by a Certificate IV level course, whilst current apprenticeships are generally offered at Certificate III level. This is an area governed by EE-OZ, the ElectroComms and Energy Utilities Industry Skills Council, the Australian Government declared I.S.C. for the ElectroComms and Energy Utilities industries. ARCIA are working to drive change in radio/electronics apprenticeships to reflect Certificate IV competencies.

In May, ARCIA held its first education teleconference, with representation from Universities and TAFE's across Australia. The theme for this virtual meeting was based upon training availability, and course content, with the intent to provide an information database of program availability, and development of rapport with these RTO's in future meetings.

In terms of new programs, one of particular interest is the proposed Graduate Diploma in Spectrum Management, which is to be offered in block delivery in Canberra. This program is intended to provide the necessary training for Spectrum Assigners.

The need for support of members in actively engaging apprentices/trainees remains unchanged from last year, and is of critical importance if we want radio training to remain available in Australia – clearly our RTO's are now driven by economics, and it is not viable to maintain course availability without minimum student numbers.

# SCHOLARSHIPS AND CHARITY

In 2010-2011, ARCIA, on behalf of Tait Radio Communications, awarded the inaugural Sir Angus Tait Memorial Scholarship to Nic Persic in NSW and Ben Woods in SA.

The Sir Angus Tait Memorial Scholarship is intended to provide encouragement to students or apprentices who are undertaking specialised training within the radio communications field. Sir Angus Tait recognised that those students of today, with a passion for communications, are our future, and took pride in promoting and supporting technical education.

In order to continue to provide encouragement to students or apprentices actively pursuing study leading to a career in radio communications, four Sir Angus Tait Memorial Scholarships will be awarded in 2011/2012 thanks to the support from Tait Radio Communications, Omnnitronics and RadioComms Connect 2011.

1. Are illegal and grey imported radios affecting your business ?




Over recent years with increasing international on line trading and growth of low cost radios appearing from emerging markets, there was feedback this was effecting the professional market segment. 78% indicated this to be true.

2. When considering a new digital radio solution which aspect most Influences your choice?




As an industry the migration to new digital technologies represents new opportunities, but poses the question, 'what influences buying decisions?' Clearly the market seeks value for money and operational fit as most important. The loyalty to brand appears less important.

3. Would a small number of low cost/low power UHF frequencies allocated strictly for business digital communications by ABN holders be of benefit to the radio industry and users?



As part of better Spectrum management and delivering the right options to business users, the notion of a GMRS style frequency set has been voiced for Australia. Overwhelmingly, members concurred that a small set of Business channels would deliver benefit to users and the industry specifically for ABN short range business applications.

#### 4. What key area is holding back your business growth?




Competition from other wireless technologies 0%

- Recruiting technical staff 55.6%



Over 90% of respondents sought from the ARCIA website more technology training and technical information. With this feedback, ARCIA will endeavour to work towards providing these materials for our members.

6. Laptops/Smartphones and PDA's are changed out every 3 years on average, however, professional radio users expect greater product longevity. What should be a reasonable life of a professional radio?



Radio users expectations are moving with the times and life expectancy for radios coming back to 3-5 years. This falls within the curve of Laptops life-cycles as business essential tools that should be upgraded when needs arise.


